

Release, Waiver of Liability and Consent

I, \_\_\_\_\_, understand that horseback riding is a dangerous and hazardous athletic event and a horse environment poses potentially serious risks of injuries to its participants and/or observers. I understand that I, or my minor, may be injured as a result of my negligence, the negligence of others, or through no fault of myself or anyone else, because of the nature of the activity in which I, or my minor, am going to be engaged or observed. I also understand that horses, even the most well-trained, are often unpredictable and often difficult to control, and that no one has represented or stated to me that horses within the common environment are "safe" or "quiet" or have any specific or particular qualities.

With knowledge of the foregoing, and as an inducement for Richard Johnson, Diamond J Horses, Lori Schiavone, Jim Peratt, Liberty Oaks Ranch their agents, or employees or contractors, race assistants, race sponsors, Los Angeles County Fair, owners, managers, employees, and spectators, I hereby waive or release (to give up) any and all rights that I may have to make a claim against any of them arising from any damages, injuries or death which I, or my minor, might sustain as a result of horseback riding and/or related activities, my association or proximity to horses or domestic animals or objects within the common environment. I further agree to indemnify (to insure and to hold harmless) Richard Johnson, Diamond J Horses, Lori Schiavone, Jim Peratt, Liberty Oaks Ranch their agents, or employees or contractors, race assistants, race sponsors, Los Angeles County Fair, owners, managers, employees, and spectators and owners of the horses from any and all claims which I might make or which might be made on my, or my minor's behalf by others, or which be made against me or them, by others arising from my, or my minor, renting or leasing or allowing me, or my minor, to ride a horse or to be within the common environment.

The common environment is defined as the properties identified in total by the address and environs: Los Angeles County Fair Grounds, Pomona California.

By signing this release and waiver, I am assuming all risks of the activities in which I, or my minor, will be engaged and associated with and on the common environment and releasing all parties indicated above any and all liability for their negligence or association. I do assume all risks and responsibilities involving myself and any party of whom I am responsible in having on/in the common environment and to waive and give up my rights (for myself and my heirs) to sue or bring such an action, and I do so knowingly and voluntarily.

Release is valid indefinitely.
